### 4. First Aid Measures

**Ingestion:** If any component of this kit is swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.

**Skin Contact:** If any component of this contacts the skin, flush with copious amounts of water and wash with soap and water for at least 15 minutes. Remove contaminated clothing and shoes. Call a physician if irritation or discomfort develops.

**Personal precautions :**No action shall be taken involving any personal risk or without suitable training.Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. **Environmental precautions :** Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
