BACKGROUND

CD147/EMMPRIN (Extracellular Matrix Metalloproteinase Inducer), also known as Basigin (BSG), is a transmembrane glycoprotein with different forms resulted from different modes of glycosylation and N-terminal sequence variants. It is a member of the immunoglobulin superfamily with homology to both the immunoglobulin V domain and MHC class II antigen beta-chain. This protein play important roles in variety of events including spermatogenesis, embryo implantation, neural network formation. CD147 induces the production and release of matrix metalloproteinases (MMP) in the surrounding mesenchymal cells and tumor cells, and thereby promotes invasion, metastasis, growth and survival of malignant cells. Furthermore, CD147 also serves as a receptor for extracellular cyclophilinthe and its association with integrins might be important in signal transduction. Recently, CD147 displays increased expression in many cancers, and it has been previously demonstrated to participate in cancer metastasis and progression. Thus, CD147 and its antibody are used as an effective treatment for malignant cancers.

PRINCIPLE OF THE TEST


The Novus Biologicals EMMPRIN/CD147 Antibody Pair [HRP] is a solid phase sandwich ELISA (Enzyme-Linked Immunosorbent Assay). It utilizes a monoclonal antibody specific for EMMPRIN/CD147 coated on a 96-well plate. Standards and samples are added to the wells, and any EMMPRIN/CD147 present binds to the immobilized antibody. The wells are washed and a horseradish peroxidase conjugated rabbit anti-CD147/ EMMPRIN monoclonal antibody is then added, producing an antibody-antigen-antibody "sandwich". The wells are again washed and TMB substrate solution is loaded, which produces color in proportion to the amount of EMMPRIN/CD147 present in the sample. To end the enzyme reaction, the stop solution is added and absorbances of the microwell are read at 450 nm.

INTENDED USE

◆ The Human EMMPRIN/CD147 Antibody Pair [HRP] is for the quantitative determination of Human EMMPRIN/CD147.

 This EMMPRIN/CD147 Antibody Pair [HRP] contains the basic components required for the development of sandwich ELISAs.

ASSAY PROCEDURE SUMMARY



This antibody pair has been configured for research use only and is not to be used in diagnostic procedures.

MATERIALS PROVIDED

Bring all reagents to room temperature before use.

Capture Antibody – 0.5 mg/mL of mouse anti-EMMPRIN/CD147 monoclonal antibody, Dilute to a working concentration of 4.0 µg/mL in CBS before coating.

Detection Antibody – 0.5 mg/mL rabbit anti-EMMPRIN/CD147 monoclonal antibody conjugated to horseradish-peroxidase (HRP). Dilute to working concentration of 0.125 μ g/mL in detection antibody dilution buffer before use.

Standard – Each vial contains 25 ng of recombinant EMMPRIN/CD147. Reconstitute standard powder with 1 mL detection antibody dilution buffer. After reconstitution, store at -20° C to -80° C in a manual defrost freezer. A seven-point standard curve usi ng 2-fold serial dilutions in sample dilution buffer, and a high standard of 400 pg/mL is recommended.

SOLUTIONS REQUIRED

CBS - 0.05M Na₂CO₃, 0.05M NaHCO₃, pH 9.6, 0.2 µm filtered

TBS - 20 mM Tris, 150 mM NaCl, pH 7.4

Wash Buffer - 0.05% Tween20 in TBS, pH 7.2 - 7.4

Blocking Buffer - 2% BSA in Wash Buffer

Sample dilution buffer - 0.1% BSA in wash buffer, pH 7.2 - 7.4, 0.2 µm filtered

Detection antibody dilution buffer - 0.5% BSA in wash buffer, pH 7.2 - 7.4, 0.2 µm filtered

Substrate Solution : To achieve best assay results, fresh substrate solution is recommended

Substrate stock solution - 10mg / ml TMB (Tetramethylbenzidine) in DMSO

Substrate dilution buffer - 0.05M Na₂HPO₄ and 0.025M citric acid ; adjust pH to 5.5

Substrate working solution - For each plate dilute 250 µl substrate stock solution in 25ml

substrate dilution buffer and then add 80 μ l 0.75% H₂O₂, mix it well

Stop Solution - 2 N H₂SO₄

PRECAUTION

The Stop Solution suggested for use with this antibody pair is an acid solution. Wear eye, hand, face, and clothing protection when using this material.

STORAGE

Capture Antibody: Aliquot and store at -20 $^{\circ}$ C to -80 $^{\circ}$ C for up to 6 months from date of receipt. Avoid repeated freeze-thaw cycles.

Detection Antibody: Protect it from prolonged exposure to light. Aliquot and store at -20 $^{\circ}$ C to - 80 $^{\circ}$ C and for up to 6 months from date of receipt. Avoid repeated freeze-thaw cycles.

Standard: Store lyophilized standard at -20 $^{\circ}$ C to -80 $^{\circ}$ C for up to 6 months from date of receipt. Aliquot and store the reconstituted standard at -80 $^{\circ}$ C for up to 1 month. Avoid repeated freeze-thaw cycles.

GENERAL ELISA PROTOCOL

Plate Preparation

1. Dilute the capture antibody to the working concentration in CBS. Immediately coat a 96-well microplate with 100 μ L per well of the diluted capture antibody. Seal the plate and incubate overnight at 4 °C.

2. Aspirate each well and wash with at least 300µl wash buffer, repeating the process two times for a total of three washes. Complete removal of liquid at each step is essential for good performance. After the last wash, remove any remaining wash buffer by inverting the plate and blotting it against clean paper towels. 3.Block plates by adding 300 µL of blocking buffer to each well. Incubate at room temperature for a minimum of 1 hour.

4.Repeat the aspiration/wash as in step 2. The plates are now ready for sample addition.

Assay Procedure

1.Add 100 μ L of sample or standards in sample dilution buffer per well. Seal the plate and incubate 2 hours at room temperature.

2. Repeat the aspiration/wash as in step 2 of plate preparation.

3. Add 100 µL of the detection antibody, diluted in antibody dilution buffer, to each well. Seal the plate and incubate 1 hour at room temperature.

4. Repeat the aspiration/wash as in step 2 of plate preparation.

5. Add 200 μ L of substrate solution to each well. Incubate for 20 minutes at room temperature (**if substrate solution is not as requested, the incubation time should be optimized**). Avoid placing the plate in direct light.

6. Add 50 μ L of stop solution to each well. Gently tap the plate to ensure thorough mixing. 7. Determine the optical density of each well immediately, using a microplate reader set to 450 nm.

CALCULATION OF RESULTS

• Calculate the mean absorbance for each set of duplicate standards, controls and samples. Subtract the mean zero standard absorbance from each.


• Construct a standard curve by plotting the mean absorbance for each standard on the y-axis against the concentration on the x-axis and draw a best fit curve through the points on the graph.

•To determine the concentration of the unknowns, find the unknowns' mean absorbance value on the yaxis and draw a horizontal line to the standard curve. At the point of intersection, draw a vertical line to the x-axis and read the concentration. If samples have been diluted, the concentration read from the standard curve must be multiplied by the dilution factor.

•Alternatively, computer-based curve-fitting statistical software may also be employed to calculate the concentration of the sample.

TYPICAL DATA

This standard curve is only for demonstration purposes. A standard curve should be generated for each assay.

PERFORMANCE CHARACTERISTIC

SENSITIVITY

The minimum detectable dose of Human EMMPRIN/CD147 was determined to be approximately 6.25 pg/ml. This is defined as at least three times standard deviations above the mean optical density of 10 replicates of the zero standard.
